PRESENTATIONS

RAPRD Community Center - Hayes McCoy and Katie Hammer

Hayes McCoy, RAPRD Board Chair and Katie Hammer, RAPRD Executive Director proposed the idea of a possible land swap. The original Cascade Swim Center was built on Redmond School District property in 1974 when the population of Redmond was 6,000. Now, with over 40,000 people in the Redmond area, they need a larger facility. They would like to propose the possibility of building their new recreation center on the existing property, as well as expand it to include the land our transportation department, softball and soccer field are located. RAPRD owns a piece of property on SW 35th Street and Hwy 126 and would propose moving our transportation department to that location. At this point, RAPRD would just like permission to move forward with the proposal. They will be doing a mid to late September polling and would like to include the possibility of the location as an option. The Board agreed RAPRD could move forward with the possibility of a proposal.
